All Vendors Must Have The Following

- (d) City of Los Angeles Business License.
- (e) All Vendors must provide their own, canopy, tables, and accessories.

Rules & Regulations

- (f) Booth Vendors are responsible to keep their area in proper form.
Any unacceptable activity in the rented area can result in automatic termination of the contract without any refund. Vendors will be liable for any damage done to the facilities, grass/artificial turf in their designated area.
- (g) Absolutely **No Alcohol** and **No Drugs** are to be sold on the premises.
- (h) No bottle containers or food items are to be sold from the Arts & Crafts booth.
- (i) After load-in, All Vehicles must park in the designated parking area. No vendor vehicles will be allowed to stay inside the compound.
